**Minutes of the meeting held on 13 May 2014** were proposed by Leslie Prescot, seconded by Sue Laing and approved unanimously, no amendments being made.

### 1. Matters Arising:

**Progress on website:** Charlotte Every, Sue Laing, Pat Sly and Felicity Rutland had met to discuss this topic. Sue Laing advised the website would be up and running by the end of this year. The domain name is <a href="www.Remenhamparish.org.uk">www.Remenhamparish.org.uk</a>. It is intended to be explicitly a village/community website with tabs to include the Church, PCC, Parish Hall and Parish Council. #### 2. Finance Report:

In his absence Nigel Gray advised through the chairman, he had transferred monies from the Parish Hall account to enable payment of the Parish quota.

#### 3. Parish Hall

Father Martyn advised the Parish Hall is completely compliant with all safety regulations. However the Parish Hall garden wall is perilous in places and in need of urgent attention making this a priority item on the Parish Hall agenda.

#### 4. Deanery Synod

#### **Henley Deanery Synod Meeting on 4 June 2014**

After confirmation of the co-option of the Secretary, Treasurer and Quinquennial Inspection Officer, notice was given of a Churchwardens' supper on June 6 in the

Chantry House. The Visitation Court for the swearing-in of Wardens by Bishop Colin had taken place in May at St Thomas of Canterbury, Goring.

The speaker was Inspector Mark Harling, who gave a presentation on the work of the Thames Valley Police which covered having to contend with a cut of 20%; the Thames Valley link up for video conferences between Henley, Didcot, Thame and Abingdon; and a band of volunteers attend weekly to carry out administrative work, which frees police to do their main work. There has not been a rise in crime rates in the last year. Inspector Harling suggested that Synod members might form an Adopt-a-cop scheme to pray for local constabulary.

The Revd Paul Boughton was introduced. He has taken on the parishes of Goring, Streatley and South Stoke.

The next Synod meeting is a Bring and Share Supper to be held on 4<sup>th</sup> November in Henley, the exact location to be decided later.
