### 160/16: APOLOGIES FOR ABSENCE

#### 161/16: DECLARATIONS OF INTEREST

PG declared an interest in 166/16 (Whitehill Farm); no other declarations of interest were made.

#### 162/16: MINUTES OF THE MEETING

It was AGREED that the Deputy Chairman be authorised to sign the minutes of the meeting held on 13 Sept 2016 as a true record of that meetina.

#### 163/16: MATTERS ARISING

It was decided to ask PSI to seek Parish Hall agreement on the wallmounted pull-down projector screen, similar to an example provided. There were no other Matters Arising other than those appearing in the agenda of this meeting.

#### 164/16: THAMES VALLEY POLICE (TVP)

Having introduced himself , AL, described policing developments in Bracknell/Wokingham. He thought that TVP could provide more Remenham -specific information for the website and Newsletter and would endeavour to interact/engage even better with Remenham. JM asked about typical response times. TVP encouraged Neighbourhood Watch and Speed Watch schemes. The Chairman said that residents already looked out for each other. It was AGREED that the Speed Watch scheme might be useful. It was AGREED that RPC would contribute £200 to TVP.

# 165/16: NEIGHBOURHOOD PLAN (NP)

FR said that the analysis of the NP questionnaire was about 50% complete. It was AGREED that the NP would change to reflect the current climate and the questionnaire feedback and that for the moment FC should ask Steve Hounsome (SH) to delete the present version from the website.

### 166/16/16: PLANNING

On 162288 (Malmesbury; private polo facility) JH suggested that (since most of RPC-recommended conditions had been accepted by the applicant) he should drop RPC's listing. PG expressed some reservations, but JH's suggestion was AGREED.

On 162686/162676 (Unit 7/8; Whitehill Farm) the meeting considered comments from BN, aerial photographs of the site over a period of years, statements in the application and information from Companies House. It appeared that sites 7/8 were open spaces rather than buildings. It was thought that these may not have been in continuous use for over 10 years on the present scale and that present working may not by compliant with WBC conditions. The possibility of a visit the site was mentioned. RPC was also concerned that an application for an even larger facility with a wider range of inputs might appear in the future. It was AGREED that The Clerk would write to WBC Planning indicating RPC's concerns.

It was AGREED on 162707 (Century House) that the application was a small variation on what had already been approved and that The Clerk should write to WBC Planning to indicate that RPC had no comments.

On 162367/368 (Stonebridge) it was noted that there were a worrying number of enforcement notices on this. RPC AGREED that The Clerk would write to WBC Planning to indicate that it objected to these applications.

#### 167/16: WEBSITE

The Clerk reported data from SH on recent usage of the website over the last month. RPC noted that FC was now in charge of the website, while The Clerk was responsible for compliance issues and SH terms.

#### 168/16: LICENSING;

CL raised concerns about the Rewind Festival.

#### 169/16: TRAFFIC AND HIGHWAYS

The Chairman described initiatives to improve air quality in Henley where DP had made a good contribution. CL suggested any scheme would need to ensure that lorries could turn onto the bridge as they headed for Remenham. JH also outlined the situation of RAG, WBC Highways, bollards and bulb planting. PSI said that the lane to the Parish Hall appeared to have no name; JH AGREED to speak to relevant WBC Staff on the matter.

## 170/16: WOKINGHAM, HENLEY AND FOOTPATH ISSUES
