Minutes of the meeting held in the Parish Hall on 9th March 2020 starting at 8:00pm and finishing at 9:20pm (circulated 31st March 2020)

026/20: APOLOGIES FOR ABSENCE

There was one apology from Bill Ronald.

027/20: DECLARATIONS OF INTEREST

There were no declarations of interest. The Chairman provided the Clerk with an updated DoI. The Clerk asked other Councillors to update theirs.

028/20: MINUTES OF THE MEETING

It was AGREED that the Chairman be authorised to sign the minutes of the meeting held on $10^{\rm th}$ Feb 2020 as a true record of that meeting.

029/20: MATTERS ARISING

The Clerk updated the meeting on the status of Glebe Land. Pat Sly said she had relevant papers that could be available.

030/20: CHAIR/DEPUTY CHAIR

JM announced he wished to step down as Deputy Chair. JH asked for offers to take up the Deputy Chair role. DP said he was happy to act. This was AGREED.

031/20: WEBSITE

FC said that website use was down a little, but its use was still remarkably strong.

032/20: PLANNING AND LICENSING

Two planning matters were noted: Henley Bridge (200300) and Greensleeves (200458). After some discussion its AGREED that JH would take action on 200458.

033/20: FOOTPATHS AND HIGHWAYS

JH updated the meeting about the consultation on the 30mph extension on the A4130 and parking bays on Remenham Lane. DP mentioned increased activity in White Hill Woods. CL asked about the damage to the S-bend and missing bollards in Remenham Lane. JH described the uncertain status of a drive affecting the new proposed wild trail alongside Wargrave Road that he said would need to be considered. It was AGREED that any design-construction work on this trail would need 3 quotes. CL asked about the availability of a definitive or interactive map for Remenham.

034/20: HENLEY AND WOKINGHAM MATTERS

CL mentioned issues of light pollution in Remenham.

035/20: FINANCIAL MATTERS

The Clerk indicated the on-line banking payments that had been made in the last month (attached) that had been agreed at the Feb meeting (024/20). It was agreed that he should complete a standing order to take over website

domain payments. The Clerk said that PKF were awaiting instructions on audits, but that Pat Sly had agreed to undertake the internal audit. With regard to obtaining a new contractor for emptying some dog-waste bins, the Clerk said he was in discussion with Volker Highways. JH suggested that he contact the Clerk at Wargrave Parish to ask about who now empties their dog-waste bins and then determine whether they would also be able to provide a quarterly caged lorry collection.

036/20: OTHER MATTERS

CL suggested RPC that in the context of the emerging COVID-19 threat RPC might want to update its Emergency Plan – possibly with a link from the Remenham website to WBC plans/announcements. DP said one could consider the use of 'yellow ribbons' for those self-isolating. JH thought it was important to have open lines of communication at this time. DP told the meeting about a burglary in Remenham and wondered whether number-plate recognition would be helpful in Remenham. Pat Sly mentioned that the bench on White Hill had been damaged by a tree fall, but appeared to have been repaired.
