During the financial year ended 31 March 2022, this authority's internal auditor acting independently and on the basis of an assessment of risk, carried out a selective assessment of compliance with the relevant procedures and controls in operation and obtained appropriate evidence from the authority.

The internal audit for 2021/22 has been carried out in accordance with this authority's needs and planned coverage. On the basis of the findings in the areas examined, the internal audit conclusions are summarised in this table. 

VARIANCE REGISTER (AGAR page 5) for Remenham Parish Council (RPC) 2021-2022

Item 3. Receipts: The decrease of £28585 (-91%) is accounted for by no further CIL monies being received from the Borough Council in 2021-2022.

Item 4. Staff costs: The decrease of £842 (-13%) is due to a one-off payment to (i) the website manager (SH; £600) in 2020-2021 for work towards making the Remenham website compliant with legal requirements and (ii) an extra payment to The Clerk for additional CIL work (£242) in 2020-2021 not being made in 2021-2022.

Item 6. Other payments: Another double-sized litter bin was purchased this year; all our payments were similar to last year.

Item 9. Fixed assets: These increased by £2692 (+33%) on inclusion of a double Wybone litter bin (£1081), biodiversity towpath signs (£851) and log parking controls (£622).

(i) RPC was *still* unable to carry out planned CIL expenditure of approximately £34000 by the 31st March 2022 while waiting for Planning/Highways/Property approvals from the Borough Council. This expenditure will take place in the autumn of 2022.

(ii) This will be followed by

- (a) £10000 expenditure on its Local Plan based on enhancing the quality of life for residents and
- (b) £5000 on a legal review of licensed events in the Parish.

This will reduce its reserves by £49000 in the 2022-2023 year significantly
