#### FROM THE RECTORY

Dear friends.

It seems to me that contemporary society has a complicated and uneasy relationship with the human body.

We live our lives increasingly through technology, engaging with the version of reality represented on a screen rather than the space our bodies actually occupy, and relating to people through telephone or computer rather than the people who are physically present to us. There seems to be ever-increasing angst about physical appearance. There appears to be a growing phenomenon of young people feeling at odds with their bodies in profound ways, believing themselves to be "born in the wrong body", and sometimes seeking major medical interventions as a result. We often speak of our minds and our bodies as if our minds were like a computer operating the sometimes defective machinery of our bodies. We see mind and body, or perhaps soul and body, as being two rather different things, detached and disconnected from one another. Modern science increasingly suggests something very different, with increasing evidence of the profound links between body and mind, and the complex ways in which the health of one impacts on the health of the other.

Many people assume this mind/body dualism to have roots in Christian faith, but this isn't quite right. Mind/body dualism could be found in the ancient Greek philosophical tradition, which had a significant influence both on ancient Judaism and on early Christianity, and this strand of thinking remained strong in the western philosophical tradition: think for example of Descartes' "I think therefore I am". But the bible presents a quite different model. St Paul writes of the body as being the "temple of the Holy Spirit"; it is more than a shell or a husk, or mere machinery operated by the computer of the mind. And most profoundly, in the Christmas story we celebrate "the Word made flesh", God's revelation to humanity not in ideas or words but in a whole human being, both body and mind. Similarly at Easter we celebrate a Resurrection which is described in the gospels in physical, bodily terms.

During this season of Lent, Christians have traditionally sought to discipline their bodies through fasting. This may take the form of abstention from meat and other rich foods, and some reduction in the overall quantity of food consumed. This is often misunderstood as coming from a desire to punish the body, or even from a hatred of the body. But in fact the very opposite is true. We have an holistic understand of human life, in which the whole human being is a part of God's work of salvation. It is worth training and disciplining our bodies just as it is worth disciplining and training our minds, because both are loved by God, and both are redeemed through Jesus Christ, "the Word made flesh".

Francis and Margaret Spratley for their background work.





Well, we are off to a flying start to the year with a second 'notes from' already demanded by our charming and ferociously efficient editor!



No matter the challenges and frustrations we are presented with we will continue to press on for the benefit of you, our Parishioners.

Our February meeting was successfully chaired by Franky Cookson due to my absence courtesy of holiday commitments.



Gigaclear had been requested to update on their progress. Three work windows were scheduled to conclude by 24th March which they advise will allow connection to properties to begin by end of April. Please ensure you have registered your interest via the Gigaclear website to review the plans on offer. We will all have the choice of staying with our current





To our delight and partial disbelief we now have Wokingham planning approval for the long awaited improvement to the muddy puddles area at the entrance to the Parish Hall. The work is being scheduled for May and access to the hall will be maintained throughout the installation of the new block pavias.

We have agreed to refurbish the oak signs on the towpath and install similar signage on the nature trail along the Wargrave road. Finally, Ferry lane in Aston will also have oak signs to remind visitors to park responsibly.

We met with Wokingham Highways department to highlight a number of outstanding issues. Following the successful installation of double white lines along the Middle Culham stretch of the A4130 pressure has been increased to attend to the disintegrating mid section of Aston Lane. Hopefully some results will be forthcoming and included in future updates.

Other risk reducing works have been requested on overgrown pavements along the A4130.

Please remember our community clear up day scheduled for a 9.30am start at the Parish Hall on Saturday 25th March where safety kit and equipment for litter picking will be available, followed by coffee and cake when the good work is done later in the morning. Our councillor Darrel Poulos has begun planning for the task of cleaning up the many dirty and partially obscured roadsigns in the Parish..... clearly targeting a large slice of cake!



#### **MEDIATION**

Some of you will have seen the article about Mediation in the recent edition of 'Round and About' - written by our very own Hugh Whitfield. I was intrigued and invited Hugh to tell us more, by answering a number of my curious questions, which he has very kindly done. **Editor** 

#### **MEDIATION - HUGH WHITFIELD**



For a number of years I have been receiving instructions from solicitors to act as a medical expert witness in cases of alleged medical negligence and for claims made by people injured after accidents. I had become increasingly concerned that the focus had shifted from the injured person. The aggressively confrontational approach between the legal teams for the claimant and for the defendant generated fees for lawyers (and for medical experts like me) but all too often led the claimant along a stressful and lengthy litigation process, the outcome of which was unpredictable. For example, in cases of alleged

medical negligence, one third of the claimants receive no compensation. After the Event (ATE) insurance ensured that the lawyers were not often out of pocket even when the claimant had been awarded nothing. When compensation was awarded, the claimant could find that they were responsible for some of the costs. In other types of civil litigation the same confrontational approach occurs.

Some five years ago I decided to take a course on mediation. For me, this was a 'Road to Damascus' experience'. Having qualified as a mediator I have been able to apply the skills that I learned in a wide variety of scenarios.

Mediation is one form of alternative dispute resolution that does not involve litigation. It is entirely voluntary. Although mediation is not legally binding, it can be if the participants so wish. The Ministry of Justice is consulting to see whether it should become mandatory in many areas of civil litigation.

Disputes between participants can be settled in very many different situations, financial, contractual, landlord/tenant, family, probate, workplace, neighbour and employment disputes, divorce settlements, disputes between residents and their families in care homes and nursing homes, as well as medical negligence and accident claims.

The participants need to agree to go to mediation and to choose a mediator. Mediators are trained to explore avenues for settlement. They are completely impartial. The success rate is more than 90%.

If there are any disadvantages it is that there is no 'winner'. By the same token there is no 'loser'. Neither party will come away with everything that they had wanted but they will have participated in and have ownership of the outcome, rather than have a decision imposed on them.

Other great advantages are that the costs will be known in advance and are limited to the mediator's fee and the hire of a venue for the meeting. Each participant may be accompanied by whoever they like, a family member, a friend, a lawyer or all three. Mediation meetings commonly last half a day or a full day.

If no agreement is reached participants can pursue litigation. Nothing that has been said at the time of a mediation meeting can be used during the litigation process.

Supplementary message to the Editor from Hugh: 'I have answered most of your questions in what I have written. I can't say how much time it takes as it varies from week to week. To become a mediator you have to have been on a course and then paid a subscription to one of the four main organisations (actually they are businesses). CEDR, Civil Mediation Council, Society of Mediators and Clerksrooms all offer a 'stamp of approval' after you have shown that you have been on a course and had an annual update (preferably by them) and paid your money. CEDR do not recognise the training offered by anybody but themselves. So the rivalry between them all is intense. None of them will quarantee you work! The only mediation that I have done through the Society of Mediators, with whom I trained, was a free Mediation project in the Royal Courts of Justice for two months in the summer, as part of an initiative to reduce the backlog in the County Courts of small claims and some fast track ones. It was organisationally a shambles, so I thought better not to go there! I mediate with Resolve Mediation in Reading and they do not charge a fee for being on their books, but they do charge for update courses! The MoJ has used/abused the term of mediation by arranging for some court officials (exactly what level I do not know) to offer "mediation" over the phone to one party at a time without there being a joint meeting. As with pretty well everything the politics are convoluted!!

Whilst on the subject of Hugh Whitfield - Hugh has initiated what is now a series of Life Saving Courses at the Parish Hall. (It was just going to be one, then two, but both were almost instantly oversubscribed, and plans are now place for a third.) See below. As Hugh says 'Most of us know of unexpected events that have been life threatening. They can affect people of all ages. When the event is closer to home we may be motivated to take a Life Saving Course. These courses are now available.' Editor

#### LIFE SAVING COURSES

A Life Saving Course is available at Remenham Parish Hall on Friday 24th March, probably at 1.00pm. This is a three hour course that will cover CPR at different ages, drowning, hypothermia, shock, choking, anaphylaxis and aspects of trauma.


The numbers are limited to 14 to ensure that all participants can become involved.

The cost is £40.00 per person. All participants will receive a Certificate and a booklet.

#### PARISHIONERS OF THE PAST- PART I

Having finished turning out his father's desk, Paul Cook has transcribed and typed up some reminiscences from the late Rev. Pettit, and thought they might be of interest to readers of the newsletter. I'm sure he's right as they make fascinating reading, with some familiar names. This is the first part of these and the second part will be published in the next issue.

Editor

"The death of dear Christine (Heaven) Fitzgerald of Green Isle a few months back, was always a sadness to me. Though I could but not rejoice that she had gone to join her beloved Maurice. But the death too, brought back to me memories of my very first Parochial Church Council when I came to Remenham in 1949, for she was the last member of it to be still actively worshipping at Remenham Church.

What a splendid body of people they were, all so able and experienced. Their memories deserve to be perpetuated, and I will, if my recollection serves me right, try to recall them all. What they could have thought of the youngish Parson shot from a distant Welsh parish into their midst I do not know, for they were for the most part far older and wiser than myself. If they had doubts there were kind enough to keep them to themselves.

First and foremost was Mrs Jeakes of Marsh Mills, who was the epitome of wisdom and shrewd, sound good sense. I had, quite frankly an enormous admiration for her.

Everything she said was to the point and with wit and good humour. But with this too, she was so kind and thoughtful and generous to me and my young family with sudden unexpected surprises. I thought her, and still think of her as a wonderful woman and count it my good fortune to have met her.

Mr Jeakes, whose memorial tablet is in the church, was already failing when I came. He had been a splendid man and such a great servant of his church. I always wished I had had more time to know him. By Mrs Jeakes' generosity I inherited a great part of his library, the library of a well read and cultivated gentleman. But her gift was typical of a very gracious lady.

Then there was Major and Mrs Rhodes of Common Barn. The Major was a soldier to his fingertips but he and Mrs Rhodes were Remenham to their fingertips too. The Major had taken a very active part in local politics and was, I believe, a leading force, if not the leading force in the old Remenham agricultural shows. He did not live long enough for me to get to know him as well as I should have.

Mrs Rhodes was a delight and such fun to be with. When I first came she was compelled to use walking sticks to get about. Afterwards there had to be a wheelchair. Yet with all her pain, I never remember a single word of complaint from her. What Major and Mrs Rhodes' achievements were when young I do not know. They seemed to me to have been everywhere and seen everything. I fancy Mrs Rhodes had run a hospital at one time in the war years (1st world war). She was certainly a visitor to Broadmoor for many years. But to visit her when she was greatly confined to home was one of my main pleasures in Remenham and she gave me many entertaining hours.

Colonel and Mrs Rivers Moore lived on Remenham Hill. Mrs Rivers Moore was a sister of Dr Staines Read, our local doctor, and a semi invalid for most of the time I knew her. Colonel Rivers Moore was a character. As an ex sapper he could turn his hand to anything. He cut the church lawns, swept and unblocked an unyielding chimney for us, rolled our own rectory lawn into proper order. Any practical difficulty, call Colonel Rivers Moore was the motto of the rectory and he was there. At the same time he had other arts. The tapestry he had done was if I remember rightly, remarkably fine. I think he had tackled it whilst in a hospital bed. His construction model of Hurley Priory was really something. He had been resident in Ladye Place Hurley, before coming to Remenham and had conducted extensive explorations of its ancient site and finally I believe became Chairman or President of the Berkshire Archaeological Society. He sang in the choir somewhat robustly, and could get a surprisingly moving and plaintive tune from the saw. A smart and upright man with absolutely no side. He was never absent from church — as regular as clockwork — and I missed him greatly when he left the parish.

Miss Marjorie Ansell of Remenham Terrace was our secretary and one of the nicest and kindest of people; always charitable, always seeing the best in everyone. I have to confess that sometimes I played a little game with an unsuspecting Marjorie. When, in the early days she drove me to practice with the Remenham Singers, I would find fault deliberately with someone just for the joy of waiting for the moment, which I knew would come when Marjorie would speak up in defence and find some excuse for whoever it was. That is if she could not come up with something nice. It never failed – not once. As I said, she was the kindest of people. Latterly, she came I thought, to dislike heartily the world she lived in as it was portrayed by the radio and newspapers and indeed it was alien to her gentle spirit.
