LICENSING; Parish profile data (TC)/Cumulative Impact Data (CIA)

On 7th April Neil Brown, Michael Dudley and Ron Emerson of Remenham Farm Residents Association (RFRA) circulated minutes of the March 11th Wokingham Borough Council Licensing Committee (WBCLC) with some comments about where a cumulative impact assessment (CIA) can be assessed. RPC could not attend – having its own mtg that night.

It appears that WBCLC will acquire detailed event impact data in 2024 with a view to having this available for a WBCLC meeting in Jan or March 2025.

The Clerk (TC) at RPC is producing detailed event impact data from March to October 2024 held on the RPC website and updated each month with a view to providing this to WBCLC and RFRA. RPC has set aside funds (£10K) for hardware and for this purpose. It will consider computer modelling of these data.
